Please note that Local Government Regulations do not permit the award of grants to individuals. Grants will not be awarded to cover staff salaries.

## Criteria for grant applications

Applications will be accepted from voluntary/charitable groups and organisations, not for profit organisations or community interest companies, but not from individuals.

The group/organisation must benefit the parishioners of the City of Ely and the project/activities should take place within the parish of Ely, to allow funding to be considered.

The Council is encouraging applications with regard to funding 'one off' projects or to support unexpected costs related to the pandemic. They would not encourage applications that were purely for supporting the organisation's running costs.

Grants cannot be provided to cover employment costs.

The Council will, through a monitoring process, seek confirmation of how your funding has been spent.

All grants must be spent within 12 months of receipt. If this is not confirmed, then further applications will not be considered. The Council may, in certain circumstances, reclaim the grant if not spent or if the group/organisation ceases to exist.

All applications must be received by the deadline date in February to enable them to be considered.

Applications will be considered at the next Personnel, Finance and Governance Committee meeting in March 2021. Recommendations for awards from this Committee will go before the Full Council meeting in April 2021 for approval or refusal. Applicants will then be notified of the outcome of their application.
